Focus of the OA movement

- Scholarly, peer-reviewed content
- Both gratis and libre
- Levelling the playing field among researchers worldwide
- Allowing all citizens to share the results of publicly funded research
- Reducing cost of print libraries and materials

The Gold Route (Gold OA)

- Primary publication in an open access journal
- Often requires author publication fees
- Some non-OA journals offer a hybrid gold OA option, where you can pay a surcharge to make your article available OA
- Be aware of predatory publishers and journals that exploit the gold OA model for profit.

The Green Route (Green OA)

- Publish article in journal of choice
- Deposit article in an institutional or subject repository
 - York's institutional repository is [YorkSpace](#)
- Subject to publisher policy/permission
 - Look up your publisher's policy in Sherpa/Romeo
 - If policy is restrictive, ask to retain the right to deposit your work in a repository when signing author agreement

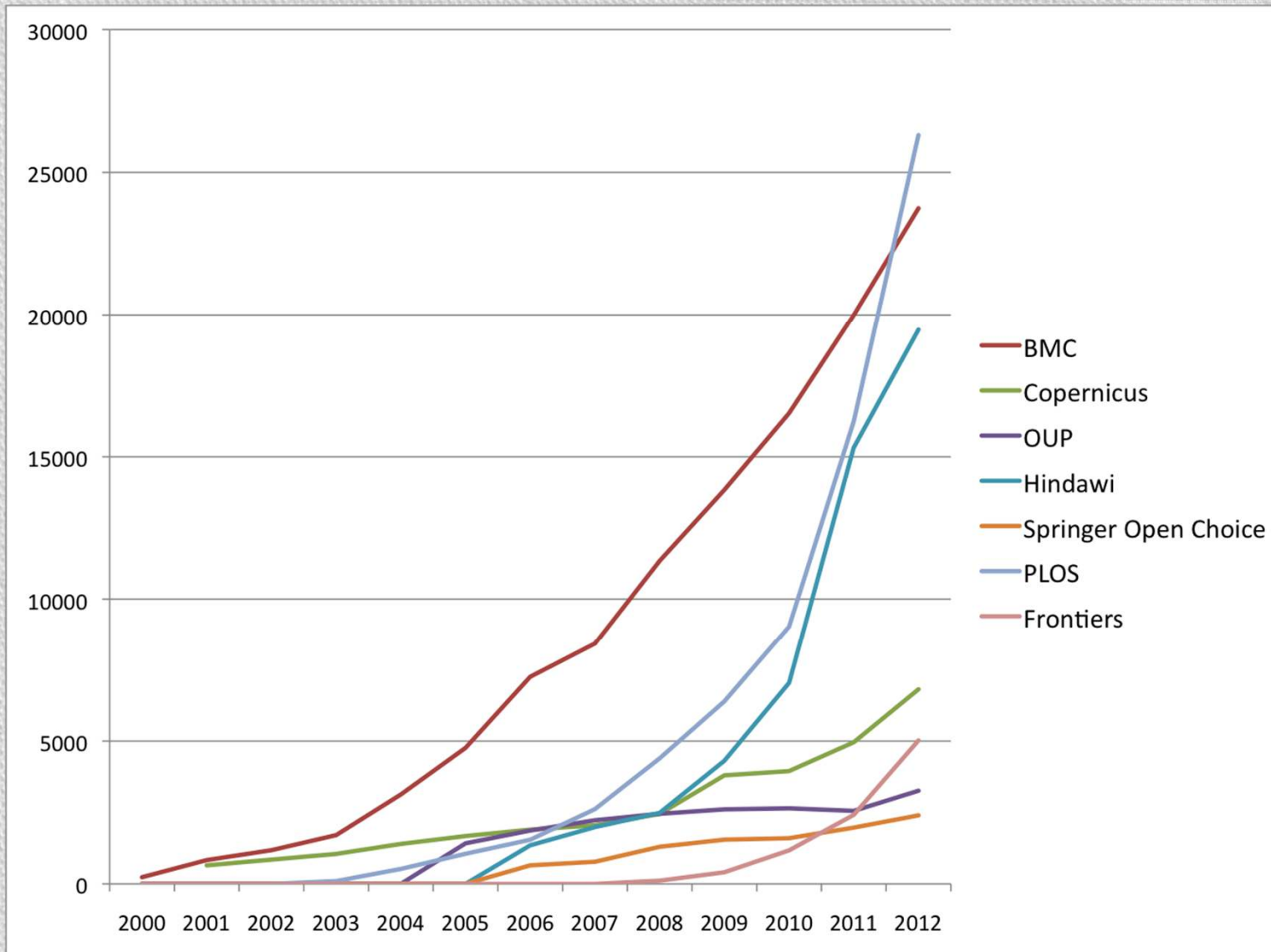

JULIET assigns Open Access ticks (✓) for the key conditions that should ideally be met for each type of policy. If a policy encourages but does not require a key conditions, a dash (—) is shown instead.

Draft Tri-Council OA Policy

All journal articles must be available open access within 12 months.

Option 1 - “Gold route”

- Publish in an open access journal (including hybrid)

Option 2 - “Green route”

- Publish in journal of choice, place a copy of article in repository within 12 months of publication (this is called self-archiving)

Applies to:

- Canadian Institutes of Health Research (CIHR)
- Natural Sciences and Engineering Research Council of Canada (NSERC)
- Social Sciences and Humanities Research Council of Canada (SSHRC)

York University Libraries Open Access Fund

- Eligibility notes:
 - Biomed Central, Hindawi, PLoS, PeerJ, RSC (others may be considered if they are not predatory)
 - Note PLoS has discontinued its membership program but is still eligible for funding by the YUL OA fund
 - Hybrid or embargoed journals are not eligible, the journal must not charge any fees for any of its content
 - The first author must be York affiliated
 - Potential support for claiming one paper per year
 - Only researchers with no other funding source to cover APCs will be considered for funding
 - THE FUND IS LIMITED: please fill out the application form to determine eligibility

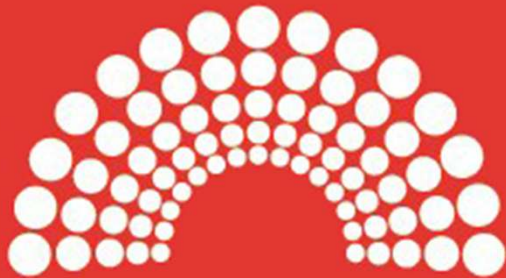

Why Manage Research Data?

Effective data management will:

- **Save time:** Planning for your data management needs ahead of time will save you time and resources in the long run.
- **Increase your research efficiency:** Have you ever had a hard time understanding the data that you or your colleagues have collected? Documenting your data throughout its life cycle *saves time* because it ensures that in the future you and others will be able to understand and use your data.
- **Facilitate new discoveries:** Enabling other researchers to use your data reinforces open scientific inquiry and can lead to new and unanticipated discoveries. And doing so prevents duplication of effort by enabling others to use your data rather than trying to gather the data themselves.
- **Meet grant requirements:** Many funding agencies now *require* that researchers deposit in an archive data which they collect as part of a research project.
- **Support Open Access:** Researchers are becoming increasingly more aware of the need to manage their work and consider issues of scholarly communication. The Open Data movement advocates for researchers to share their data in order to foster the development of knowledge.
- **Increase Research Impact:** by maximizing the visibility of the data and promoting transparency in search
- **Ensure compliance:** to meet the requirements of the institution or funding agency
- **Improve accessibility:** ensuring that the quality and integrity of the data is maintained during and beyond the life cycle of the project
- **Safeguard research data:** by establishing appropriate storage, back-up and management

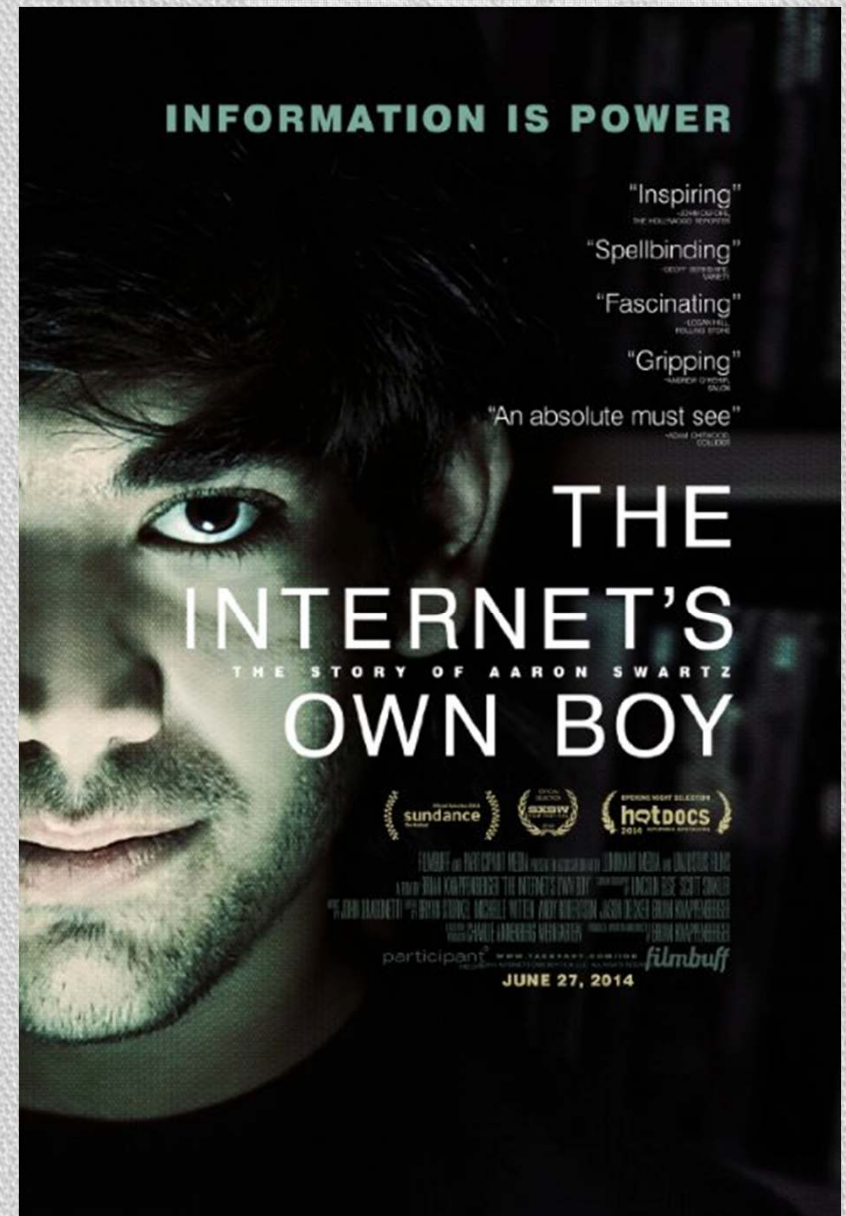
