1. Chair's remarks

Chair H. Edgell welcomed Council members.

She reminded Council members and guests to sign the attendance book and note dates and time of upcoming Council meetings.

2. Minutes of the Meeting December 7, 2016

V. Persechini moved, seconded by Professor N. Khanlou, that the minutes of the December 7, 2016 meeting of Council be approved.

The motion carried (via electronic vote).

3. Business Arising from the Minutes

There was no business arising from the minutes.

4. Dean's Remarks

Dean McDonald welcomed everyone to 2017. He acknowledged that the School of Kinesiology and Health Science program was ranked as 21st in the world by Shanghai Ranking's Global Ranking of Sport Science Schools and Departments. He commented that the Department of Psychology underwent accreditation with the Canadian Psychological Association and received very positive feedback.

In 2017, Dean McDonald felt that we have an opportunity to build on our previous foundations. He stated that Health is well positioned to respond to domestic and global challenges and drive the dialogue that will be forming around the concerns of healthy aging.

Dean McDonald also announced that the internal deadline to submit AIF proposals to Associate Dean Murtha (hlthadtl@yorku.ca) is Monday, January 23, 2017 at 4pm. Also, YFile will be profiling stories about teaching and learning every third Friday of the month. If you feel a colleague should be profiled for their work or research he urged faculty members to submit a profile.

5. Faculty Council Update 2016

R. Lenton, Vice-President Academic and Provost and G. Brewer, Vice-President Finance and Administration presented to Council.

- R. Lenton briefly discussed the Strategic Mandate Agreement (SMA) and explained that a more detailed presentation on SMA will be given at Senate in the near future. She spoke about how enrolment appears to be stabilizing due to efforts in conversion and retention. The University seems to be hitting its targets on both conservative and stretch targets that are being set for Visa students. They are just short of the stretch targets in domestic numbers. Target numbers for Masters Programs are not being attained.
- R. Lenton also spoke about the IIRP. She highlighted that items typically fell into three categories: to be to be developed: supported and to be celebrated/rewarded. They will the assess recommendations put forth by Councils to determine which items will have the greatest priority in advancing the University Resource Plan and will work to develop those items at a pan-university level.
- G. Brewer provided information on the Provincial Government reforms to the University Funding Formula. The way in which universities' receive money from the government will be different and will include three core areas of funding: enrolment, student success and special purpose grants. No new funding is being introduced; it is simply a redistribution of existing funding. This new model will be equitable and predictable and allow for greater transparency.
- G. Brewer also provided a budget update. It included information on the context for budget planning, the 2015-

2018 and 2016-2019 Budget Plans and the key budget planning assumptions and emerging budget risks.
