#### 1. Chair's remarks

Chair N. Richardson welcomed Council members and thanked Joel Goldberg, Chair, Department of Psychology and his colleagues for hosting Council and for setting up equipment to facilitate Adobe Connect.

She reminded Council members and guests to sign the attendance book and note dates and time of upcoming Council meetings. She also encouraged faculty to contribute to future Media Briefs by informing F. Clarke of upcoming events, research, publications etc.

#### 2. Minutes of the Meeting March 7, 2018

Prof. L. Beagrie, moved, seconded by Prof. M. Morrow, that the minutes of the March 7, 2018 meeting of Council be approved.

The motion carried.

#### 3. Business Arising from the Minutes

There was no business arising from the minutes.

#### 4. Dean's Remarks

Dean McDonald echoed the Chair's gratitude and thanked the Department of Psychology for hosting Council.

He congratulated the Department of Psychology who in the previous few days had been once again ranked among the top 100 psychology programs in the world and tied for top four in Canada by QS World University Rankings. Given the number of universities in the world and in Canada who offer psychology, being in the top 100, and doing it on a repeated basis is a remarkable achievement. This week the Shanghai Global Ranking of Sport Science Schools and Departments also released their latest rankings. In another extraordinary achievement, the School of Kinesiology and Health Science moved up 5 places from 21st last year to 16th place this year in the world, and the best School in Canada.

Dean McDonald congratulated Prof. C. Mallette, who was awarded the Quality Compassionate Caring Award; Prof. S. Walkerley, who won an award for Excellence in Teaching and Prof. G. Percival who received the Clinical Instructor Award from the Council of Ontario University Programs in Nursing.

Dean McDonald congratulated the following faculty members for being appointed as York Research Chairs:

- Prof. J. Elder from Psychology, Tier 1 York
   Research Chair in Human and Computer Vision
- Prof L. Sergio from Kinesiology and Health Science, Tier 1 York research Chair in Brain Health and Skilled Performance

- Prof. J. Wiess from Psychology, Tier 2 Chair in Autism and Neurodevelopmental Disability.

Dean McDonald noted that Prof. R. Pillai Riddell was awarded a Teaching Award by Faculty of Graduate Studies.

He acknowledged the work of M. Hamadeh and J. Rawana, College Heads, for their continuing excellence and dedication. For example, they jointly wrote and submitted a proposal to the Ontario Ministry of Education worth several hundred thousand dollars to advance student experience and success within the Faculty of Health. The proposal was ranked as the top proposal in the University.

The Dean congratulated Prof. D. Hood for receiving a CIHR grant. Additionally, although the details are still under embargo, we understand that 5 applications from the Faculty of Health will receive funding from SSHRC. This puts us on a course to potentially pass our record 2017-18 external research funding success of \$20 million, which is a 10% increase over our 2016-17 funding total and a 94% increase since 2015-16. Our level of growing success is a function of the quality, innovativeness, and importance of our work and demonstrates why it is important that more colleagues consider submitting research proposals to tri-council agencies and other peer reviewed competitions.

He noted that students in Global Health returned from their Winter 2018 internships and commended the efforts of faculty and staff for setting-up extraordinary opportunities. Our students completed work terms for the WHO in Sri Lanka, the Health Aid Society in Jordan, a health environmental group in Costa Rica, to name a few. He also encouraged faculty to connect with J. Hard

(<u>ilhard@yorku.ca</u>) to discuss connections and research opportunities.

Dean McDonald highlighted that he will visit each academic unit to share and discuss policy documents such as the Integrated Resource Plan and Strategic Plan.

Lastly he acknowledged the CUPE 3903 labour disruption and thanked faculty, staff and students for their continued efforts, cooperation, patience and dedication, as well as the need to maintain respectful and collegial dialogue.

## 5. Presentation: Calumet & Stong @ 2020 Annual Update

M. Hamadeh, Head of Stong College, and J. Rawana, Head of Calumet College, presented Calumet & Stong @ 2020 Annual Update.

The College Heads recapitulated initiatives from 2015 and noted 2018 goals which included:

- Expanding course representatives program
- Piloting online peer tutoring
- Expanding student-club embedded programs
- Expanding Indigenous Circle Program
- Renovating Stong Junior Common Room
- Conducting a Student Engagement Survey (currently under ethics review)
- Submitting Academic Innovation Fund, Bell Let's Talk Community Fund and Canada Service Corps Grant applications

The Colleges' Strategic Plan, Vision, Mission and Values are embedded into the following themes:

- Orientation and transition
- Academic support programs
- Leadership Exploration and Development
- Community Building and Development

College Heads explained each theme by providing an overview of associated programs, noting strengths and discussing future recommendations.

College Heads invited students I. Azari and H. Saif to speak to initiatives and reflect on their experiences. Both I. Azari and H. Saif commented that various activities have contributed to their learning and have developed their leadership skills. A discussion ensued about supporting the development of leadership courses based in the Colleges with positive feedback from the students.

Faculty were encouraged to connect with College Heads to discuss programs and additional recommendations.

**6.** Report of the Executive and Planning Committee On behalf of the Executive and Planning Committee, Prof. M. Morrow noted that processes to fill vacancies on Standing Committees of Council were underway in Schools/Department. Members were encouraged to connect with their nominating committee for additional information.

There was a call for nominations for the vacant position of Chair of Council from July 1, 2018 to June 30, 2019. No nominations were received from the floor.

This position will remain vacant until filled.

There was a call for nominations for two "at-large" seats on the Executive and Planning Committee from July 1, 2018 to June 30, 2020. It was noted the two 'at large' members shall not be from the same School/Department.

Prof. B. Meisner expressed an interest in serving as a 'atlarge' member on Executive and Planning.

Seeing no additional nominations, Prof. B. Meisner was acclaimed.

The remaining 'at-large' position will remain vacant until filled.

There was a call for nominations for the vacant position of an "at-large" seat on the Petitions Committee from July 1, 2018 to June 30, 2020. It was noted that Prof. H. Tamim, School of Kinesiology and Health Science, is a continuing member and the two 'at large' members shall not be from the same School/Department.

No nominations were made from the floor.

This position will remain vacant until filled.

There was a call for nominations for the vacant position on Senate Sub-Committee on Honorary Degrees and Ceremonials, from July 1, 2018 to June 30, 2021.

Prof. C. Ardern expressed an interest in serving the Senate Sub-Committee on Honorary Degrees and Ceremonials.

Seeing no additional nominations, Prof. C. Ardern was acclaimed.

Members were encouraged to submit nominations to fill vacancies to L. Sadhwani by Friday, April 13, 2018.

Associate Dean P. Safai moved and Prof. M. Hamadeh seconded to extend Council by 15 minutes.

The motion carried.

#### 7. Senator's Report

Senator Belcastro attended the March 22, 2018 meeting of Senate.

Senator Belcastro noted, as recommended by the Academic Standards, Curriculum and Pedagogy Committee, Senate approved:

- Establishment of a Cross-Disciplinary Certificate in Culture, Medicine and Health, Department of Anthropology, Faculty of Liberal Arts & Professional Studies
- Establishment of a Disciplinary Certificate in Advocacy & Public Engagement, Department of Anthropology, Faculty of Liberal Arts & Professional Studies
- Establishment of an Honours Minor Degree Option in Advocacy & Public Engagement, Department of Anthropology, Faculty of Liberal Arts & Professional Studies
- Establishment of a Privacy and Cybersecurity Specialization in the Professional LLM Program, Osgoode Hall Law School / Faculty of Graduate Studies
- Change in degree requirements for the Masters in Environmental Studies Program, Faculty of Environmental Studies / Faculty of Graduate Studies

Senate also received two hortative motions. The following was approved:

Senate hereby expresses its view that Senate, in conjunction with Senate Executive, has the authority to direct and determine that classes be suspended on the basis of academic integrity.

The following motion was defeated:

It is the opinion of Senate that all classes on the Glendon campus should be suspended for the duration of the CUPE 3903 strike.

The Academic Policy, Planning and Research Committee (APPRC) reported:

- the Committee's endorsement of the establishment of a task force to examine possibilities for CV management software
- reflections on the APPRC-ASCP February Forum of Ideas and consideration of ways to share knowledge gained as the committees seek to advance University Academic Plan objectives related to quality and innovation
- consultations on the development of "Incomparable Metrics" that will include Faculty Councils and the York University Libraries
- Faculty Planning Submissions: Status and Goals
- the latest update on Markham Centre Campus planning from the Provost

Senator Belcastro highlighted that Senate is scheduled to meet on April 26, 2018.

#### 8. Other Business

An inquiry was raised about financial reimbursement for students who have had their labs cancelled due to the CUPE 3903 labour disruption. It was noted that for some students this was their second CUPE 3903 labour disruption.

Referencing the Senate Policy on the Academic Implications of Disruptions or Cessations of University Business Due to Labour Disputes or Other Causes, it was noted that students have academic liberties and responsibilities. That being said, Senate and various

central services are developing remediation plans and fundamental to plans is the student experience.

An attendee also asked about Independent Study Courses and was recommended to connect with the appropriate academic unit for specific information and guidance.

The meeting was adjourned.

Report of the Petitions Committee of the Faculty of Health Council May 2018

#### **ITEM FOR INFORMATION:**

#### **Year End Report 2017 – 2018**

The Committee members review material via Moodle and note individual decisions prior to weekly in-person meetings. Beginning in January 2018, the Committee also piloted the Zoom Conferencing system to host virtual meetings for members who are unable to attend in-person meetings due to extenuating circumstances.

In 2016-2017, a total of 1063 files were adjudicated. In comparison, a total of 839 files have been adjudicated with 20 petitions currently pending in the same time frame during the 2017-2018 term. This represents an 21.07% overall reduction in petitions from last year. There has also been a 24.8% drop rate in late withdrawal petitions from last year, which may indicate expanded awareness and promotion of the Withdrawn from Courses option, whereby students may take the initiative to opt for a "W" on their record up until the last day of classes.

Even with the W option, the most common petition request is still withdrawal from courses. The Faculty received 558 such petitions in 2017-2018, of which 8% were granted for full removal, 54% granted for withdrawal only (i.e. W) and 38% were refused. The rates in the other categories of petitions have remained consistent reflecting similar numbers as last year.

A new type of petition emerged in 2017-2018, whereby students appealed for a full removal of courses that had been withdrawn (W) via a previous petition. Students shared that the removal of the course was necessary to initiate a financial petition with Student Financial Services. Another common reason was concerns about how the W would be viewed by graduate school admissions committees. (Note: removal of courses from the transcript are considered only on grounds of sufficient documented hardship or non-participation in the course, per the Senate Policy on the Withdrawn from Courses option.)

Beginning in 2018, the Office of Student and Academic Services in collaboration with the Coordinator, Student Academic Petitions, began offering various webinars on petitions-related topics to target audiences as part of their outreach and retention strategy. Webinars will continue to be offered following the release of 2017-2018 final grades and academic decisions.

In March 2018, the Faculty of Health also introduced a third adjudication panel (Panel C), composed of the Associate Dean, Teaching and Learning, the Manager of Student Services in the Faculty of Health, and the Director, Student & Academic Services & Strategic Imitative. Panel C will be mainly tasked with alleviating peak periods (such as the summer months after the release of final grades and academic decisions). Given the newness of the Panel and that academic decisions have not yet been released, its direct impact on assisting with overload has not yet been assessed. Data will be collected, and trends will be noted in future reports.

The Petitions Committee will once again participate in their semi-annual Policy Meeting held in June 2018 to discuss Senate Policies and Guidelines and other key initiatives.

The chart below summarizes petition regulations adjudicated by the Petitions Committee between July 6, 2017 and April 12, 2018, inclusive.
